

CAMH Health Law Articling Opportunity 2024-2025

CAMH combines clinical care, research, education, policy development and health promotion to help transform the lives of people affected by mental health and addiction issues. CAMH is fully affiliated with the University of Toronto, and is a Pan American Health Organization/World Health Organization Collaborating Centre.

CAMH, as a teaching hospital, strives to be a centre of academic excellence. CAMH Legal Services is doing its part to meet this objective by offering one student an articling position for the 2024-2025 articling term starting in August 2024. The articling position is aimed at keen law students with a proven interest in the field of Health Law and, more specifically, Mental Health Law. CAMH is a complex and multi-faceted healthcare organization with both litigation and corporate legal needs. The successful applicant will be expected to work with our Clinical Legal Services Team, providing legal support to CAMH's clinicians, physicians, and administrators. The student-at-law will gain exposure to a range of work including Consent and Capacity Board hearings, Ontario Review Board hearings, appeals at the Superior Court of Ontario and Ontario Court of Appeal, policy development, government submissions, educational initiatives, provision of legal advice, and other legal writing. The aim of the articling opportunity is to offer students an opportunity to gain substantive, practical and real-life experience in mental health law in an in-house, hospital environment. While all applicants will be considered, those students interested in health law are likely most suited to the role.
