Services offered: Support for people trying to find and maintain affordable housing through partnerships and referrals; services include housing help, access to income benefits and ID replacement, help getting furniture, links to treatment and rehabilitation services and assistance with activities of daily living

Eligibility: People with mental health problems including addictions who have recent or current criminal justice involvement and who are homeless or are at risk of becoming homeless

Referral: To apply for the program, complete the referral form on their website and fax it to 416 289-6843

Services offered: Short-term case management and community support to help link people to mental health services and reduce their risk of criminal arrest

Eligibility: People age 16 and older who have a mental health concern and are at risk of incurring criminal charges, are facing criminal charges or have recently had charges before the court

Referral: Referrals can be made by the individual, family, police, probation services, court personnel and other service providers by completing the referral form on the website

Services offered: 395 supportive housing units in Toronto with a high level of flexible support

Eligibility: People age 16 and older who are involved in the criminal justice system, are homeless or at risk of being homeless, have independent living skills and can be safely supported in the community

Referral: Referrals are only accepted from priority referral sources: police, correctional facilities, probation and parole officers and law and mental health programs; the referral can be made through the Access Point (on their website) or by calling 416 640-1934

Referral: A referral form must be requested from Cota and can be completed and submitted by any caregiver, professional and prospective client

Eligibility: People age 16 and older living with a serious mental illness in the North York community; the person must also meet one of the following criteria: referred by police officer or probation officer who identified the person as moderate to high risk of being charged with an offense, currently facing charges or released from jail within past year, living with five or more risk factors (as listed on their site)

Services offered: Anger management programs, Reintegration Service trailer in parking lot of South Detention Centre (see address above) provides support for people being released from jail or returning to pick up their property, such as counselling, clothing, food, TTC tokens, a place to check emails, charge cel phones and accompaniment in the community; Lakeshore site - assessments, referrals, snacks, overdose prevention information, harm reduction/education tools, naloxone; Homes for Good, provides help finding housing and intensive follow-up support to men post-incarceration; pre-employment programs; S.T.E.A.M. Strategies Towards Employment Anger Management offers support to maintain employment and communicate positively; Record Suspension (Pardons) Service provides help people applying for a Record Suspension; Relapse Prevention Program offers weekly group and individual counselling to help men break the cycle of addiction.

Eligibility: Varies by program: anger management is for mandated and voluntary clients but men with domestic-related charges must first successfully complete a domestic violence program; S.T.E.A.M. is for male Ontario Works recipients looking for work who may have poor conflict resolution skills and/or limited success in personal relationships

Referral: Referral processes vary by program; to get connected with services, contact the number listed above or review the services on their website for alternative contact information

Fees: Some fees will apply. Record Suspension support is \$365 plus applicable fees.

Services offered: A Ministry of Health and Long-Term Care program made up of LOFT, CMHA, COTA and Houselink that connects people with safe and dignified housing and provides mental health, employment and crisis support

Eligibility: People age 16 to 64 who have a serious mental illness, are homeless or at risk of being homeless and are currently involved in the criminal justice system

Referral: A referral is made through the Access Point by completing the online referral form; it can be made by Mental Health Court Support programs and associated court-based case management programs (link to referral form: hub.theaccesspoint.ca/referralForm_0.php)

Eligibility: Anyone who needs help replacing or obtaining legal ID
